From Boston (All Points South)

Follow Interstate 495 North to Exit 44, Merrimack Street. Follow signs to loop around to Merrimack St. Then follow directions below, starting at the second line.

From Portsmouth (All Points North)

Follow Interstate 495 South to Exit 44, Merrimack Street. Take a Right at Stop sign on to Merrimack Street. Turn Right into Riverwalk Entrance A, approximately .2 miles. Building One will be straight ahead. IMAJINEthat is on the 2nd floor on the West side of the building. Use the Building A entrance. We are located on the 2nd floor directly above Salvatores restaurant.
